Requirements while you and your dog are involved in training classes with Purrfect Dog Training (these may vary according to the class):

- Owner(s) of the dog must have Liability Insurance (eg homeowners or general liability).
- Puppies should be spayed/neutered if older than age of 5 months.
- Dogs that are ill or in season are not permitted in training– attend without dog and continue working at home.
- Due to insurance regulations and for safety, all handlers must wear sneakers or shoes with rubber soles. No high heels, sandals, leather soles, bare feet, or foot gear determined by the instructor to be inappropriate will be permitted.
- A responsible adult must accompany children under 17 years of age at all times.
- Purrfect Dog reserves the right to excuse any dog or handler for behavior deemed inappropriate or disruptive if in a class.
- For the safety of all concerned, dogs deemed extremely aggressive will be dismissed or muzzled from training at the discretion of the Training Staff.
- It is your responsibility to call and confirm whether or not you will not be able to make a training session. Money will not be refunded, (will possibly work out a missing session).
- Note the day and time of training sessions we have agreed on. Training interviews and paper work are on the first day of training and is regarded as a training session.
- All training learned has to be the responsibility of the owner to continue training lessons. A dog can become untrained very quickly if allowed. Understand the dog will never forget it's training, but will check to see what they can get away with. Make sure you are consistent with the commands and do not allow them to get away with "sneaking" out of one. Be firm! (not abusive)
